The TSP will send a 1099-R to the IRS (and a copy to you) classifying the move as a rollover, with no penalties or taxes due. After five tax years you can withdraw the amount that you rolled over into that Roth IRA, and that amount is free of penalties & taxes.

IRS Form 1099-R — The TSP has mailed IRS Form 1099-R, Distributions From Pensions, Annuities, Retirement or Profit-Sharing Plans, IRAs, Insurance Contracts, etc., to participants who received a withdrawal up to December 27, 2019, and/or a taxable distribution of a loan up to December 31, 2019. Withdrawals processed on December 30 and 31 are taxable income for 2020.

Report the amount listed under gross distribution on the 1099-R as "Pension and Annuities," under the income section of your individual income tax return. Report the amount under "Taxable Amount," next to the distribution amount under the income section of your tax return form. On the 2010 Form 1040, this is on line 16.
